The following Council members answered roll call: Mr. Bernstein, Mrs. McSwiggan, Mr. Strauch, Mrs. White, Mrs. Wilczynski and Mayor Barra. Ms. LaMonica was absent. Also present was Mrs. McCarthy.

Mr. Barra stated that this meeting is for the purpose of appointing and welcoming two new Police officers to the Police Department. A more formal and public swearing in will be held at the Council's next meeting on January 24<sup>th</sup> at 8:00 p.m. Family and friends are also welcome to attend at that time.

Resolution 13-58 – Introduced by Mr. Bernstein, seconded by Mrs. Wilczynski

**Be It Resolved** by the Governing Body, upon recommendation of the Chief of Police and Public Safety Committee that Kevin Azevedo and Jamie Hillgardner are hereby appointed as patrol officers of the Allendale Police Department effective January 18, 2013 at an annual salary of \$35,000.00.

Ms. Hillgardner was sworn in by Mayor Barra.
