Committee Reports

Water and Sewer

Mrs. McSwiggan said over six hundred people have called to schedule sump pump inspections. Twenty-two violations have been noted. Mrs. McSwiggan said the response from the community continues to be very positive.

This morning she and Mayor Barra met with representatives from the Northwest Bergen Sewer Authority with regard to an infiltration study conducted in Allendale. Boswell Engineering will be doing an analysis of the San Jacinto area because they believe there is significant activity attributable to sump pumps in that area. Flows from that area are much higher than in other parts of town.

Mayor Barra noted that the study is being conducted at the expense of the Northwest Bergen Utilities Authority, not the Borough, and the study involves the local sewer lines, not the interceptor lines. It will be monitored from a metering pit on Carteret Road which services approximately 250 homes in the San Jacinto area.

Mrs. McSwiggan said Allendale is beginning to explore having the sewer authority take over the Borough's sewer maintenance work once United Water begins handling the operation of the Water Department. Northwest Bergen Utilities Authority will give us an estimate of the cost for that service.

A final agreement with United Water is very close to being accomplished. She commented that it has been an interesting and positive process with good communication on both sides of the table.

Mr. Barra noted that when the contract with United Water is finalized, a special meeting of the Council will be held to authorize it. A fourteen day notice period will offer the public an opportunity to review the contract. An open public meeting will also be held to review the contract with representatives of United Water present. After the public hearing is concluded, the contract will go to the Board of Public Utilities which will sign off on it before it becomes official. The Borough is striving for a June 1, 2013 turnover date. Generally the approval process takes two months.

Public Safety

Mr. Bernstein was absent.

Land Use and Construction Code

Mr. Strauch said the Land Use and Construction Code Committee will be meeting tomorrow morning at 8:30 a.m.

Public Works

Mrs. White said a salt brine solution that clears the roads of ice was tested last week on Franklin Turnpike and East Allendale Avenue. The weather wasn't cold enough for the brine to work, but the concept is to coat the roads with brine up to 24 hours before a storm. It is designed to be used just before a winter storm and it will help prevent the accumulation of snow. If it works successfully, it will help to keep the roads clear and reduce overtime.

The DPW break room will be completed in the next few weeks. It will be used as a place for the DPW employees to relax when they are in Allendale for long hours during a storm.

Mrs. White said she had just heard from Allendale's FEMA representative who stated that Allendale's expenses for debris alone from Hurricane Sandy have been calculated to be \$100,647.22. Emergency services still need to be calculated to cover the cost of Police, Fire and CERT.

Personnel, Finance and Human Resources

Ms. LaMonica reported that the Finance Advisory Committee will meet on Tuesday evening to review the budget.

Facilities, Parks and Recreation

Mrs. Wilczynski said the lightning detection system has been installed and the first training session was held at the Police Department for the Police, the Schools and the Mayor and Council. Closer to Spring another training session will be held for the members of the Recreation Commission as well as the coaches. The next item to be addressed from that grant will be the playground.

Mrs. Wilczynski said a new bio-organic material, AQC-20 will be used at Crestwood Lake this season. It works to dissolve organic material and will decrease the need for chlorine by fifty percent. Also the Borough won't have to purchase the Alum that has been used previously. In addition, Copper Sulfate will not be needed to control the snails, because the AQC-20 will eliminate the material the snails eat.

Mrs. Wilczynski said AQC-20 is all natural and is not hazardous if consumed. It has been used at Graydon Pool for a couple of years. It is hoped that the use of AQC-20 will eliminate some of the issues that have occurred at Crestwood previously and also keep the lake water clear. It is anticipated that the Borough will save \$20,000 a year from the use of AQC-20. There will be a trial period and if for any reason it doesn't work as anticipated, there is a backup plan.

Mrs. Wilczynski reported that a new chlorine line has also been installed and it is operational.

Municipal Attorney

Mr. Bole did not have a report.

Municipal Clerk

Mrs. McCarthy said the new Deputy Municipal Clerk began working this week and she will start working from 10 a.m. to 3 p.m. on March 11th. She is working for two weeks from 12:00 to 4:00 and then will be working from 10:00 a.m. to 3:00 Mrs. McCarthy said Coleen Goddel is a lovely person and she hopes the Council members will stop in to meet her in the near future.

Mrs. McCarthy read the following resolution into the record:

Whereas, the Open Public Meetings Act, P.L. 1975, Chapter 231 permits the exclusion of the public from a meeting in certain circumstances; and

Whereas, this public body is of the opinion that such circumstances presently exist; and

Whereas, the Governing Body wishes to discuss Contract Negotiations,

Minutes will be kept and once the matter involving the confidentiality of the above no longer requires that confidentiality, then the minutes can be made public.

Now, Therefore, Be It Resolved that the public be excluded from this meeting.

On a motion by Mrs. White, seconded by Mrs. Wilczynski, the Council voted unanimously to adjourn to Executive Session at 8:25 p.m.
