Bidders, upon request, will be furnished with a copy

of the specifications and blueprints by the Allendale Borough Clerk. upon proper notice and a non-refundable payment cost of \$50.00 to cover the cost of reproduction. Company checks must be made payable to the Borough of Allendale. **Neither personal checks nor cash will be accepted.**

No drawings, specifications and/or proposal forms will be given out after 4:00 p.m. on Monday, November 24, 2014.

Bids must be made on Standard Proposal Forms in the manner designated herein and required by the Specifications, must be enclosed in sealed envelopes, bearing the name and address of bidder and name of project on the outside addressed to the Mayor and Council, Borough of Allendale, Bergen County, New Jersey and must be accompanied by a Non-Collusion Affidavit and a certified check or bid bond for not less than ten (10%) percent of the amount bid, not be less than \$500.00, and a consent of surety form from a surety company authorized to transact business in the State of New Jersey in a sum equal to one hundred (100%) percent of the amount bid, and be delivered to the Allendale Borough Hall on or before the hour named above.

The Standard Proposal Forms and the Non-Collusion Affidavit are attached to the Specifications, copies of which will be furnished on application to the Engineer.

The Contractor will comply with all regulations and orders promulgated by the State Treasurer pursuant to P.L. 1985, c 127. and with all provisions of the N.J.S.A. 11:2-1 through 11:2-4 and all rules and regulations promulgated there under, the provisions of which are incorporated herein by reference.

Bidders must also comply with P.L. 2004, C.57 (Chapter 57) amending and supplementing the business registration provision of N.J.S.A. 52:32-44. A contractor must include proof of business registration at the time it submits a bid or proposal. Contractor must also comply and submit proof of registration of Public Works Contractor Registration Act P.L. 1999, c. 238; N.J.S.A. 34:11-56.41 et sec. Only the successful bidder will be required to submit a completed W-9 form to the Borough Chief Financial Officer.

In the event of a tie between two or more low responsible bidders, the Borough reserves the right to make an award to any of the tie bidders. The Borough also reserves the right to increase, decrease, or remove any of the quantities without a change in unit price.

Bidders shall not rely solely upon this advertisement but shall be guided by the specifications and contract documents on file with the Borough of Allendale.

The Mayor and Council reserve the right to reject any or all bids, to award solely the Base or Alternate 'A' Bid, both, or to waive any informalities in the bidding.
