
Introduction of Ordinance 12-12

**AN ORDINANCE TO AMEND THE SALARY ORDINANCE OF THE BOROUGH OF



Authorization to Hire Dan Rosendahl





 Improvements to Powell Road and Various Streets
 Marini Brothers Construction Co., Inc.

Whereas, the Engineer has requested that certain changes are needed in the contract for Improvements to Powell Road and Various Streets, and


Whereas, a net decrease of \$36,033.48 will result from the following items:

- Accounting for additional milling on Powell Road.
- Removing all work associated with milling and repaving Lori Lane.
- Reconciling final contract quantities.

Now, Therefore, Be It Resolved by the Mayor and Council of the Borough of Allendale, County of Bergen, State of New Jersey, that Change Order Number Two resulting in a decrease of approximately \$36,033.48 be approved for Improvements to Powell Road and Various Streets. All Change Orders to date will result in a net decrease of \$32,200.48 or 13.62% less than the original contract amount of \$236,442.00, resulting in a new contract amount of \$204,241.52.

Approval of Town Wide Garage Sale





Be It Further Resolved that lawn and garden watering with both automatic and hose sprinklers are limited to the following schedule:


1. Odd house numbers: Wednesday, Friday and Sunday;

Phase 1 Water Restrictions in Effect



The demand for water in the entire region is heavy due to lack of rain and high heat. The borough's wells and supply system are severely stressed. Allendale's water supply comes not only from Borough wells, but also from United Water per agreement, supplying roughly 55% of our water. Daily usage must be reduced for safe preservation of our water supply. Please cooperate in this community effort. Neighboring municipalities in our area and United Water are also experiencing high demands on their water supply.

Lawn and Garden Watering with both Automatic and Hose Sprinklers is Limited to:

Odd House Numbers:	Wednesday, Friday, Sunday
Even House Numbers:	Tuesday, Thursday, Saturday

Monday is a system recharge day. No Watering Permitted

Hand-held hose and watering can sprinkling is permitted at all times
Use of water for other household purposes is not restricted.
