Approval of Tax Appeal Allendale Properties, LLC v. Allendale

Whereas, the tax payers, Allendale Properties, LLC appealed the assessment levied on the subject property for the years 2012, 2013 and 2014; and

Whereas, the subject property is located on Block 601, Lot 4.05 CO0004 (4 Pearl Court, Unit D); and

Whereas, the Plaintiffs were represented by counsel; and

Whereas, the Borough's expert commercial appraiser inspected the property, reviewed all the records including the pleadings and answers to interrogatories, and issued a preliminary opinion of value; and

Whereas, the appraiser and the assessor have agreed to compromise the appeal on the following terms: for the tax year 2012 the assessment will be reduced from 1,341,200 to \$1,191,200; for the tax year 2013 the assessment will be reduced to \$1,041,200; for the tax year 2014 the Tax Court Complaint will be withdrawn, however a county board petition has been filed which is scheduled for a hearing in June; and


Whereas, there are sufficient funds available in the reserve for tax appeals account to satisfy the tax refund; and

Whereas, the assessor is of the opinion that the valuation of the subject property is consistent with true value of the property.






