**ORDINANCE NO. 16-11**

**AN ORDINANCE TO ESTABLISH CHAPTER 205 OF THE CODE OF THE BOROUGH OF ALLENDALE ENTITLED "PUBLIC RECREATIONAL BATHING"**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Allendale, County of Bergen, State of New Jersey that the following Chapter be adopted and established with the Code of the Borough of Allendale:

**CHAPTER 205 PUBLIC RECREATIONAL BATHING**

**205-1 REFERENCE TO STATE CODE; DEFINITIONS.**

Reference is made to Chapter IX of the Sanitary Code of the State of New Jersey, N.J.A.C. 8:26, *et seq.* (Entitled "Public Recreational Bathing") (hereinafter referred to as "Chapter IX of the Code"). The definitions contained in Chapter IX of the Code are adopted for the purposes of this chapter.

**205-2 LICENSE TO OPERATE A PUBLIC OR RECREATIONAL BATHING PLACE.**

**205-2.1 License Required.**

No person shall operate a Public or Recreational Bathing Place until a license therefore shall have been issued by the Board of Health.

**205-2.2 Fees and Charges.**

- a. For the issuance or annual renewal of a license to operate a public recreational bathing facility within the meaning of Chapter IX of the Code: four hundred (\$400.00) dollars each.
- b. For any inspection or reinspection of a Public or Recreational Bathing Place subsequent or in addition to any inspection required for the issuance of an annual license or the renewal of an annual license required by this Chapter: seventy-five (\$75.00) dollars each.
- c. Crestwood Lake shall be exempt from the requirement to pay the foregoing fees and charges.

**205-2.3 Terms of License; Application for Renewal.**

Licenses issued for the operation of a Public or Recreational Bathing Place shall expire annually on December 31 of each year and application for renewal thereof shall be submitted together with the required fee prior to January 1 of each year.

**Denial or Suspension of License.**

Licenses required by this Chapter may be denied or suspended by this Board of Health for failure to comply with this Chapter or Chapter IX of the Code.

**205-3 VIOLATIONS AND PENALTIES**

- a. Any person or persons, firm or corporation violating any of the provisions of this Chapter or Chapter IX of the Code, shall, upon conviction thereof, pay a penalty of not less than fifty (\$50.00) dollars but not more than five hundred (\$500.00) dollars for each violation.
- b. Each day a particular violation continues shall constitute a separate offense.

**205-4 INCONSISTENT ORDINANCES AND CODES REPEALED.**


